**Your Starting Interest Rate (upon approval)**

The interest rate you pay will be determined after you apply. It will be based upon your credit history and other factors. If approved, we will notify you of the rate you qualify for within the stated range.

**Your Interest Rate during the life of the loan****Your interest rate is variable.** This means that your actual rate varies with the market and could be lower or higher than the rate on this form. The variable rate is based on the 90-day Average Secured Overnight Financing Rate (SOFR) (as published by the Federal Reserve Bank of New York). <b>3. FIXED MONTHLY PAYMENT</b> Make \$50.00 monthly payments while in school or grace. Unpaid interest will be added to the deferred principal of your loan. <b>Loan Term:</b> starting <u>after</u> the deferment period	\$10,000.00	13.43%	66 months	<b>\$21,649.82</b>

**About this example**The repayment example assumes the student remains in school for 4 years and have a 6-month grace period before beginning repayment. It is based on the **highest starting rate currently charged** and associated fees.

## REFERENCE NOTES

### Variable Interest Rate

This loan has a variable interest rate that is based on the 90-day Average Secured Overnight Financing Rate (SOFR) (as published by the Federal Reserve Bank of New York).

### Eligibility Criteria

#### Borrower

In order to obtain this loan, you must become a member of Y-12 FederalCredit Union.  
Borrower must be age of majority in state of residence at the time you apply.

#### Cosigners

Cosigner must be age of majority in state of residence at the time you apply.

### Borrower Benefits

Interest rate discount of 0.25% for borrowers who are enrolled in recurring ACH payments. This discount is only applied for payments received via the recurring ACH process.

### Bankruptcy Limitations

If you file for bankruptcy, you may still be required to pay back this loan.
