Loan Interest Rate & Fees

Your **starting interest rate** will be between

6.45% and **12.00%**

After the starting rate is set, your rate will then vary with the market.

Your Starting Interest Rate (upon approval)

The interest rate you pay will be determined after you apply. It will be based upon your credit history and other factors. If approved, we will notify you of the rate you qualify for within the stated range.

Your Interest Rate during the life of the loan

Your interest rate is variable. This means that your actual rate varies with the market and could be lower or higher than the rate on this form. The variable rate is based upon the Prime Rate (as published in the Wall Street Journal). For more information on this rate, see the reference notes.

Although your rate will vary, **it will never exceed 12.00%** (the maximum allowable for this loan).

Loan Cost Examples

About this example

The repayment example assumes the student remains in school for 4 years and have a 6-month grace period before beginning repayment. It is based on the **highest starting rate currently charged** and associated fees.

Variable Interest Rate

This loan has a variable interest rate that is based on a publicly available index, the Prime Rate, as published in the Wall Street Journal.

Borrower Benefits

Eligibility Criteria
