#### **Variable Interest Rate**

This loan has a variable interest rate that is based on the 90-day Average Secured Overnight Financing Rate (SOFR) (as published by the Federal Reserve Bank of New York). Your rate will be calculated each quarter by adding a margin between 1.75% and 10.00% to the 90-day Average SOFR. The rate will not increase more than once each quarter, but there is no limit on the amount that the rate could increase at one time. If the Interest Rate increases, your monthly payments may be higher.
