Loan Interest Rate & Fees

Your **starting interest rate** will be between

7.50% and **12.50%**

After the starting rate is set, your rate will then vary with the market.

Your Starting Interest Rate (upon approval)

The starting interest rate you pay will be determined after you apply. It will be based upon your credit history and other factors. If approved, we will notify you of the rate you qualify for within the stated range.

Your Interest Rate during the life of the loan

Your interest rate is variable. This means that your actual rate varies with the market and could be lower or higher than the rate on this form. The variable rate is based upon the Prime Rate (as published in the Wall Street Journal). For more information on this rate, see the reference notes.

Although the rate will vary, **it will never exceed 15.00%** (the maximum allowable for this loan).

Loan Cost Examples

The total you will pay for this loan will vary depending upon when you start to repay it. These examples provide estimates based on the three available repayment options.

About this example

The defer payment example assumes that you remain in school for 4 years and have a 6 month grace period before beginning repayment. It is based on the **highest starting rate currently charged** and associated fees. Repayment will last 12 years, once the initial principal payment is made. You are not required to make any payments on your loan while you are in school, although you may make payments of interest or principal and interest at any time while you are in school. Interest will be charged and added to your loan. Interest-only payments require a minimum monthly payment of \$30. Immediate Repayment Plan requires a minimum monthly payment of \$50.00.

REFERENCE NOTES

Variable Interest Rate

This loan has a variable interest rate that is based on the Prime Rate. Your rate will be calculated each quarter by adding a margin between 0.00% and 5.00% to the Prime Rate.

The rate will not increase more than once each quarter, but there is no limit on the amount the rate could increase at one time. If the interest rate increases, your monthly payments may be higher. Your rate will never be lower than 3.25% and will never exceed 15.00%.

Eligibility Criteria

Borrower

Must be enrolled at an eligible school at least half-time. In order to obtain this loan, you must be a member of Royal Credit Union.

Must be the age of majority in state of residence at time you apply.

Cosigners

Cosigner must be age of majority in the state of residence at the time you apply.

Rates may be, but are not necessarily, higher without a Cosigner.

Borrower Benefits

Interest rate discount of 0.25% for borrowers who are enrolled in recurring ACH payments. This discount is only applied for payments received via the recurring ACH process.

Bankruptcy Limitations

If you file for bankruptcy, you may still be required to pay back this loan.
