About this example

The defer payment example assumes that you remain in school for 4 years and have a 6 month grace period before beginning repayment. You are not required to make any payments on your loan while you are in school, although you may make payments of interest or principal and interest at any time while you are in school. Interest will be charged and added to your loan. Interest-only payments require a minimum monthly payment of \$30. Immediate Repayment Plan requires a minimum monthly payment of \$50.00.

Variable Interest Rate

This loan has a variable interest rate that is based on the Prime Rate. Your rate will be calculated each quarter by adding a margin between 0.00% and 5.00% to the Prime Rate.

The rate will not increase more than once each quarter, but there is no limit on the amount the rate could increase at one time. If the interest rate increases, your monthly payments may be higher. Your rate will never be lower than 3.25% and will never exceed 15.00%.
