Loan Interest Rate & Fees

Your **starting interest rate** will be between

7.60% and **12.00%**

After your starting rate is set, it will remain fixed for the life of the loan.

Your Starting Interest Rate (upon approval)

The interest rate you pay will be determined after you apply. It will be based upon your credit history and other factors. If approved, we will notify you of the rate you qualify for within the stated range.

Your Interest Rate during the life of the loan

Loan Cost Examples

| 2. PAY ONLY THE INTEREST Make interest payments but defer payments on the principal amount while the student is enrolled in school. Loan Term: starting <u>after</u> the deferment period | \$10,000.00 | 12.00% | 66 months | \$19,108.41 |

| 3. DEFER PAYMENTS Make no payments while enrolled in school. Interest will be charged and added to your loan. Loan Term: starting <u>after</u> the deferment period | \$10,000.00 | 12.00% | 66 months | \$21,220.75 |

About this example

The repayment example assumes that you remain in school for 4 years and have a 6-month grace period before beginning repayment. It is based on the **highest starting rate currently charged** and associated fees.

REFERENCE NOTES

Fixed Interest Rate

This loan has a fixed rate that will not change during the life of your loan.

Eligibility Criteria

Borrower

In order to obtain this loan, you must become a member of Wailuku Federal Credit Union. Borrower must be age of majority in state of residence at the time you apply.

Cosigners

Cosigner must be age of majority in state of residence at the time you apply. Rates may be, but are not necessarily, higher without a cosigner.

Borrower Benefits

Interest rate discount of 0.25% for borrowers who are enrolled in recurring ACH payments. This discount is only applied for payments received via the recurring ACH process.

Bankruptcy Limitations

If you file for bankruptcy, you may still be required to pay back this loan.
